## TERMS & CONDITIONS

1. Membership is valid from October for a 12-month period . **Charge will be pro-rata from signing of agreement from January 2024.**
2. Requests for resignations of membership must be in writing and received by St Francis Tourism one month prior to renewal date.
3. It shall be the members' responsibility to update their information on the website via St Francis Tourism and inform St Francis Tourism, in writing, of any changes within the members' organization viz. change of address, telephone numbers, staff changes, etc.
4. It shall be the members' responsibility to ensure that St Francis Tourism's Office has adequate supplies of brochures on display, as well as brochures in stock. We will contact you when we need more stock.
5. It shall be the members' responsibility to inform St Francis Tourism, in writing, of any changes in tariff and /or special offers available
6. Members will be invited to attend quarterly membership feedback sessions. These will serve as informal information sharing sessions whereby members can be informed about the organizations activities as well as stay abreast with what is happening in the tourism industry.
7. Fees are payable within 30 days of issue of the annual membership renewal invoice. Should membership fees not be paid within this frame, all benefits may be suspended.
8. Membership is subject to and in terms of the constitution of St Francis Tourism.
9. Members shall only be entitled to receive the benefits for which they have subscribed, **once full payment is received by 30 November.** St Francis Tourism does not guarantee reservations or referrals.
10. St Francis Tourism expects all tourism-related product owners (eg. Accommodation establishments) who wish to operate their business in a residential area apply for Council's Special consent prior to commencing business activities.
11. Tour Operators and activity service providers are required to use THETA or FGASA accredited Guides and Drivers in possession of a Professional Driver Permit (PDP). It is illegal for any business to utilize the services of unregistered tourist guides. Tour Operators to supply copies of Road Transportation Carrier Permits for each vehicle as well as proof of General Public Liability Insurance.
12. All restaurants and dining establishments to comply with standard health and safety regulations.
